WHEREAS, the UOG and COM-FSM recognize the mutual benefits of the academic articulation and transfer of course credits between UOG and COM-FSM;

## <u>AGREEMENT</u>

NOW, THEREFORE, in consideration of the terms and conditions stated below, the UOG and COM-FSM agree as follows:

- 1. That the UOG and COM-FSM will accept the transfer of credits as listed in ATTACHMENT A General Education (GenEd) Course Articulation Matrix, and ATTACHMENT B Non-GenEd Course Articulation Matrix as equivalent or comparable as per current UOG Undergraduate Catalog year 2016-2017 and COM-FSM catalogs at time of admission;
- 2. That the terms of this agreement shall commence on the day of complete execution of this agreement by all signatories and shall continue in full force and effect thereafter for a period of one (1) year unless terminated by thirty (30) days written notice from either party to the other;
