MEMORANDUM OF UNDERSTANDING AND AGREEMENT BETWEEN GUAM COMMUNITY COLLEGE AND COLLEGE OF MICRONESIA-FSM

This MEMORANDUM OF UNDERSTANDING AND AGREEMENT is entered into by and between the Guam Community College, hereinafter referred to as the GCC, and the College of Micronesia-FSM, hereinafter referred to as the COM-FSM.

WITNESSETH THAT

WHEREAS, the mission of the GCC is to provide higher education programs for the people of Guam and the Western Pacific Island communities;

WHEREAS, the GCC and the COM-FSM are accredited by the Accrediting Commission for Community and Junior Colleges, Western Association of Schools and Colleges;

WHEREAS, the GCC and the COM-FSM recognize the mutual benefits of the vocational articulation and transfer of course credits between the GCC and the COM-FSM;

AGREEMENT

NOW, THEREFORE, in consideration of the terms and conditions stated below, the GCC and the COM-FSM agree as follows:

- That the GCC will accept the transfer of credits of COM-FSM courses either as equivalent to GCC courses, or as meeting an area requirement as indicated in Attachment I.
- That the terms of this agreement shall commence on the day of complete execution of this agreement by all signatories and shall continue in full force

and effect thereafter for a period of five (5) years unless terminated by thirty (30) days written notice from either party to the other.

 That addition and/or deletion to the course listing in Attachment I can be executed by mutual agreement between both parties.
